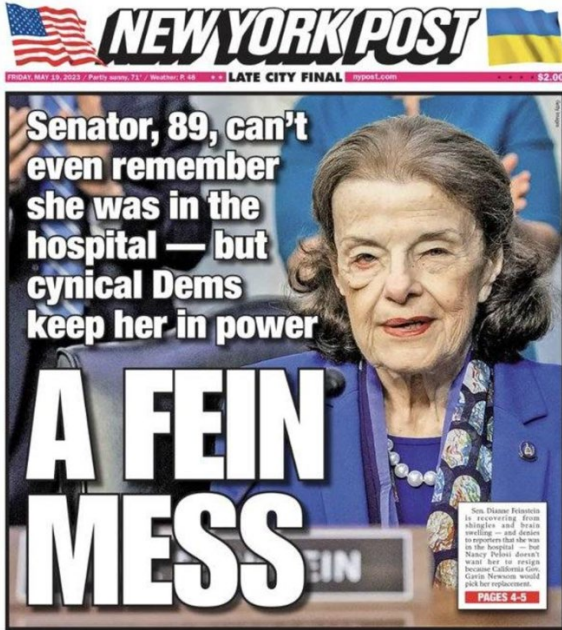
*"The fourth investigation looked into allegations made by a "well-placed" source that Hillary continued accepting those illegal donations throughout her presidential campaign."*
